

FY20-21 Key Accomplishments




Established 508
Compliance and Digital Accessibility Officer

Created this key position to lead a coordinated focus on efforts to ensure equal access to all web-based, digital, and electronic communications.



Continued Coordinated Budget Process



Subcommittees identified critical needs to improve the university's capacity to address important accessibility issues.

Established Central Accessibility Support Org & Fund Structure

Created a central accessibility support org to house the accessibility projects fund, ADA projects fund, direct accommodations fund and the live captioning fund. This structure reinforces institutional level support for accessibility and allows better tracking of accessibility projects and expenditures.

Planning, Capital Projects & Renovations


- Created an Accessibility Pathway Crew, an in-house crew to manage ADA projects on campus to include ramps, curb cuts, maintaining sidewalks, and addressing physical barriers.
- Launched and made significant progress on 6 major projects (see Appendix A for details)
- Utilized the ADA Projects Fund to complete projects to improve ramps, power doors, and strike plates in Newman Library.

Planning, Capital Projects & Renovations (Cont'd)

- In collaboration with the All-Gender Restroom Special Taskforce and the LGBTQ+ working group created All-Gender restrooms in 4 buildings on campus (see Appendix B for details) and completed a project to prioritize additional buildings to review for restroom creation
- Engaged Accessibility Consultants, Inc. a nationally recognized accessibility consultant to review accessible pathways, routing, and signage with the goal of improving wayfinding on campus.

Digital Accessibility

- Implemented post-production and live captioning service models across the university.
- Ensured access to Ally for Canvas which provides faculty feedback for improving course accessibility and students with immediate access to accessible educational materials.
- Implemented PDF remediation software pilot to ensure PDFs are accessible.
- Provided web accessibility training and support that align to WCAG 2.0 A/AA standards and enhance accessibility for those who visit VT's website.

Themes from FY21-22 Budget Proposals




Enhance & Improve Digital Accessibility



Improve digital accessibility to include captioning support, expanding access to PDF accessibility software and accessibility checkers, and tools to support accessible web design.

Improve Pathways and Wayfinding

Provide funds to design key sections of the Green Links and Infinite Loop projects to improve physical accessibility and provide a framework for addressing topographical challenges identified in the 2018 Blacksburg Campus Master Plan.



Continue Support for Physical Campus Improvements

Implement a variety of renovation and long- range physical planning projects that respond to needs identified by the campus community with a focus on the President's Quad.

Best Practices

Harness collective expertise of membership to share, compile, disseminate, and implement best practices for accessibility and universal design across learning, innovation, and service activities. Utilize G3ict's Digital Inclusion Maturity Model and Inclusive Smart University Assessment to help Virginia Tech assess and benchmark how our digital deployments and digital transformation promote and support information and communication technology accessibility.



Long Range Planning



Issue RFP for a consultant to develop strategic plan to increase all gender restrooms on campus.

Capital Projects, Renovations & Planning

- Complete funded accessibility projects identified in the Accessibility Report that are part of the Master Plan.
- Work with the All-Gender Restroom Special Taskforce and the LGBTQ+ Working Group to identify opportunities to create new single-stall, all gender restrooms on campus.
- Design Green Links sections connecting the Campbell West Trailhead from the Drillfield to the Slusher and Campbell Hall Quad and Pamplin/Robeson/Derring Quad to adjacent existing pathways west of Burruss Hall.
- Design Infinite Loop sections including the intersection of Perry and Stanger Street and along the length of Stanger Street.

Appendix A: Renovation Project Updates



FY19 - Vet Med "I" Lot Pathway Improvement

- Demo the existing noncompliant walkway and install a new ADA compliant pathway from the Vet Med "I" lot to the Vet Med entrance.
- The work on the pathway has been completed, a final inspection has passed, and the pathway is open for use. The contractor is working to complete final grading and seeding when the weather is appropriate, as well as installing roadway crosswalk.




FY20- Presidents Quad Picnic area and Pathway Improvements

- Provide schematic designs for the Presidents Quad area and construction documents for the picnic and pathway. Remaining fund will bring some of the picnic and pathway improvements.
- The design is being managed by OUP through Internal Renovations. The construction work will be managed by Internal Renovations.
- The concept/schematic design work is complete. The AE is approx. 50-60% into design of the construction documents for phase I constructions. We anticipate receiving final design late April/early May. The document will also include a conceptual cost.


FY20 - Upper Quad Pathway Improvements

- Feasibility study to provide an ADA compliant route from Stanger Street to the Upper Quad. The design/study is being managed by OUP through Internal Renovations.
- The AE has provided several options for Campus Planning Infrastructure and Facilities.
- Design and VT team met on 4/9 to review the options to discuss internally. The A/E is working to make a few corrections and submit all options to the VT team to review and meet internally to narrow down the options to 3-4. Once these options are narrowed down the A/E will provide conceptual pricing for the options and prepare the final study presentation.




FY20 - Whittemore Hall ADA Entrance Ramp

- Provided a new ADA entrance ramp on SW side of Whittemore Hall.
- The Design is completed and being submitted for permit review. Pricing is in the process of being finalized. The work is being managed by Internal Renovations.
- Construction start date is TBD Final pricing is under review. The start of construction will be coordinated around the demolition of the pedestrian bridge.




FY21 - Squires/Newman Library Walking Pathway

- Provide a new ADA pathway between Newman Library & Squires Student Center. The Design and Construction will be managed through Internal Renovations.
- The design has been completed and the drawings have been submitted for permit review and pricing. We anticipate that construction will begin late April/early May.



FY21 - ADA Improvement Requests

Provide an ADA entrance improvements into Squires Student Center. The Design and Construction will be managed through Internal Renovations.

 floor finishes, and a sink relocation will
 be required.

 Restroom. Relocation of the restroom
 entry, new floor finishes, and new
 plumbing fixtures are required.
